

**SPECIAL TOWN MEETING

ARTICLE 1. MOVED: That the Town vote to appropriate the sum of \$3,331 for the purpose of paying costs associated with the settlement of the Fiscal Year 2012 collective bargaining agreement with the TOMEA union, said sum to be raised from One Time State Aid.

PASSED/UNANIMOUS VOTE

ARTICLE 2. MOVED: That the Town vote to appropriate the sum of \$1,908 for the purpose of paying wage increases for non-union employees for Fiscal Year 2012 consistent with the new contract for the Town of Montague Employee Association, said sum to be raised from One Time State Aid.

PASSED/UNANIMOUS VOTE

ARTICLE 3. MOVED: That the Town vote to appropriate the sum of \$30,000 for the purpose of paying for a town-wide pay and classification study, said sum to be raised from Town Stabilization.

AMENDED ARTICLE: That the Town vote to appropriate the sum of \$18,000 for the purpose of paying for a town-wide pay and classification study, said sum to be raised from Town Stabilization.

PASSED/UNANIMOUS VOTE AS AMENDED

ARTICLE 4. MOVED: That the Town vote to appropriate the sum of \$20,000 for the purpose of supplementing the Fiscal Year 2012 Reserve Fund appropriation, said sum to be raised from One Time State Aid.

PASSED/UNANIMOUS VOTE

ARTICLE 5. MOVED: That the Town vote to appropriate the sum of \$15,000 for the purpose of supplementing the Fiscal Year 2012 Legal Budget appropriation, said sum to be raised from One Time State Aid.

PASSED/DECLARED MAJORITY VOTE

ARTICLE 6. MOVED: That the Town vote to appropriate the sum of \$9,000 for the purpose of preserving town records dating from 1754 to 1925, said sum to be raised from One Time State Aid.

PASSED/UNANIMOUS VOTE

ARTICLE 7. MOVED: That the Town vote to appropriate the sum of \$9,000 for the purpose of supplementing the Fiscal Year 2012 Dispatch Budget appropriation, said sum to be raised from One Time State Aid.

PASSED/UNANIMOUS VOTE

ARTICLE 8. MOVED: That the Town vote to appropriate the sum of \$40,000 for the purpose of supplementing the Fiscal Year 2012 WPCF Budget appropriation, said sum to be raised from Sewer Retained Earnings.

PASSED/UNANIMOUS VOTE

ARTICLE 9. MOVED: That the Town vote to appropriate the sum of \$25,000 for the purpose of making repairs to the Montague Center School, including but not limited to removing a fuel tank and extending the water line, said sum to be raised from Town Stabilization.

PASSED/DECLARED TWO-THIRDS MAJORITY VOTE

ARTICLE 10. MOVED: That the Town vote to appropriate the sum of \$14,000 for the purpose of purchasing and installing new energy efficient LED lighting for the Shea Theater, said sum to be raised from Town Stabilization.

PASSED/UNANIMOUS VOTE

ARTICLE 11. MOVED: That the Town vote to appropriate the sum of \$12,500 to be used in addition to federal grant monies for the purpose of purchasing and installing perimeter fencing at the Turners Falls Municipal Airport, said sum to be raised from Airport Retained Earnings.

PASSED/MAJORITY VOTE

ARTICLE 12. MOVED: That the Town vote to appropriate the sum of \$10,000 for the purpose of increasing the Henry Waidlich Conservation Fund, said sum to be raised from One Time State Aid.
