• Proposed Sewer Commission Strategic Planning Retreat

- Little feels that due to the fact that there is a lot going on with the new collection requirements, it would make sense to have a Strategic Planning Retreat with the Sewer Commission.
- Ellis adds that the context in terms of the regulatory expectations are changing around us and we need to see some holistic planning. He would like to have the planning session in July.
- In response to a question by Kuklewicz, Ellis suggests devoting a half-day to discuss this issue.
- o Kuklewicz asks Ellis, Little, and Bergeron to develop an agenda to help keep everyone on task.
- o If this is a public meeting, Kuklewicz states it should be just a brain-storming/strategic-planning session.
- o Boutwell states that once it is all planned out, then it would have to be brought to a meeting to be approved.
- o The Board prefers having a half-day session sometime in July, preferably on a Friday afternoon.

Tom Bergeron, DPW Superintendent

• Foreign Objects Pad at Transfer Station

Bergeron explains that now that we are taking more foreign objects (grits) from the headworks for the CWF, it is necessary to use a pad that gets dried, then put into a dumpster and hauled away.

• Discussion of project need, approach, and timeline

- o Ramsey has discussed this issue with Weston and Sampson. It would cost \$15,000 for the design specs.
- O Bergeron discusses using a grinder pump to pump the foreign objects into the sewer. Another possibility is a tight tank. They both have their pros and cons.
- Ramsey shares that if we were to do the construction in-house, it would cost upwards of \$200,000. If we were to bid out the whole project, it would cost about \$500,000.
- o In response to a question by Kuklewicz about whether there are other uses for a pumping system (i.e., if we end up with a composting facility), Ramsey states that the Town is in the middle of doing a Sludge Composting Facility Feasibility Study. Should the Town move forward with that facility, there would be some overlap or continuity with this project where it could tie in to this pump station. Weston and Sampson Engineers is doing that study.
- Authorize use of \$15,000 from ARPA funds (wastewater category) for design services for the foreign objects pad
- Authorize professional services agreement in the amount of \$15,000 with Weston and Sampson Engineers for design

Lord makes the motion to authorize the use of \$15,000 from ARPA funds (wastewater category) for design services for the foreign objects pad; to authorize the professional services agreement in the amount of \$15,000 with Weston and Sampson Engineers for design; and to authorize the Chair to sign the agreement. Speeding Concerns, Montague Center, Millers Falls Rd., and Lake Pleasant

- In response to residents' complaints about people speeding, Chief Williams states that there are three electronic speeding signs on Main Street in Montague Center and one on Millers Falls Road going toward downtown Millers. There have also been complaints with regard to Lake Pleasant Road. Officers have been out in their spare time running radar and stopping cars. He states it is hard to keep up with a Town our size with the size of the department that we have.
- Lord states that the roadway engineering makes it very difficult for the drivers to get the right cues.
- Lord hopes that in terms of pedestrian issues, maybe we can look into flashy blinker signs.
- Resident Corey Sutton states that he is aware that the Police Department has other responsibilities, but the residential and commercial speeding problem is getting worse. He feels that if a driver of a commercial vehicle can't stay in his lane, that he should come into Town via the Gill-Montague Bridge.
- Kuklewicz suggests asking local businesses to ask their trucking companies to use specific routes to avoid tight intersections.
- Resident Michael Marcotrigiano suggests speaking to a civil engineer consultant that specializes in traffic calming.
- Ramsey shares that the Town has implemented some traffic-calming measures (i.e., extending curbs and painting narrower travel lanes), but there certainly is more that can be done. Some measures have been identified in the Town's Complete Streets Program Plan, which is becoming due for an update. These concerns should be incorporated in the plan. The Town does have access to funding these types of projects.
- Resident Roy Rosenblatt states that in addition to the speeding issue, nobody pays attention to the crosswalks.
- Bergeron states that the flashing pedestrian lights haven't been getting used by pedestrians.
- Kuklewicz asks Bergeron to look into Lord's suggestion regarding pavement to slow traffic.
